







Migrant reception and accommodation in the context of criminalization of assistance

24 January 2020, 10:00-17:00

This workshop tackles different aspects of migrant reception and accommodation in Greece. Since the long summer of 2015, migration has been at the heart of the political agenda and the public discussion in Greece as well as in the EU. Solidarity groups, local and international organizations continue supporting local facilities on Greek islands and cities, as well as search and rescue operations against the background of increasing tensions and frictions among the receiving communities and criminalization of assistance to the extent of violating the EU and international human rights norms.

As a dialogue meeting, this event aims to bring together international and local civil society organizations, practitioners, and researchers who are working on issues related to migrant reception and accommodation in Greece. It is based on the work of the Research Social Platform on Migration and Asylum (ReSOMA) that aims to provide ready-to-use evidence on policy, policy perceptions and policy options on migration, asylum, and integration at the EU level.

The event is hosted by the Netherlands Institute at Athens in the context of NIA-IMES-VU Winter School titled "Migration in the Margins of Europe". It is designed as a series of interactive panels that will be attended by Winter School participants as well as invited stakeholders. Speakers from migrant organizations, advocacy groups, researchers and think tanks will share their first-hand experiences and evidence that concerns migrant reception and in particular the challenges that NGOs face in migrant reception, direct and indirect criminalization of assistance, strategic litigation against criminalization cases in Greece and across the EU.
